**TO THE HONORABLE MEMBERS OF THE INTER-AMERICAN  
COMMISSION ON HUMAN RIGHTS, ORGANIZATION OF AMERICAN  
STATES, AND TO WHOM IT MAY CONCERN:**

In the ever-changing forms of false imprisonment, there are deeper problems in our country than we even know. Laws have a way of legitimating prejudice, which unleashes brutality even in normally mild, respectable citizens. This encourages meanness and cruelty, even to the point of making it acceptable to kill "undesirables" among us.

At the cost of doing business, this author has been **arbitrarily detained and isolated in legal limbo indefinitely**. The extraordinary obstacles of systematic neglect have included the icy sophistry prolonging mental anguish, inhuman and degrading treatment profoundly separating her from the human family.

Kini Cosma was condemned in darkness, the victors continuing to take on this vanquished woman by extreme brutality while maintaining national silence to further threats of violence to her life, health, physical, and mental well-being. She is a wrongly convicted crime victim abused by the Criminal Justice System who has been directly and proximately harmed physically, emotionally, and financially as a result of the commission of federal offenses by City, State, and Federal officials in **Napa and Susanville in California**. And, now in **Klamath Falls, Oregon**.

## HUMAN TRAFFICKING

“The acquisition of people by improper means such as force, fraud or deception, with the aim of exploiting them. Human trafficking is a crime against humanity.”

The problem is hard to quantify because of the underground nature of the highly organized judicial network. For instance, this author was promised employment earning extensive wages in the legal industry. She went to college to study law on student loans and financial aide while pregnant *twice*. Fronting as legitimate businesses, law enforcement and the judiciary deceptively exploited this author's future and career on a wrongful conviction(s).

As a result of **excessive abuse of law enforcement and judiciary power**, this author was condemned in darkness as a "sex offender" depicting this author as a sexual object. She has had no other choice but to exhaust her meager funds and energy resisting the chicanery by City, State, Federal officials with **International appeals for justice**.

Thus, U.S. officials have completely driven Kini Cosma from the workforce<sup>1</sup> as a result of a breach of a U.S. Government promise to work in the legal field earning extensive wages. Today, as a wrongfully convicted female "sex offender" this author spends most of her time trying to keep from getting arrested on bogus charges while resisting sexual harassment, poverty, age, religious, gender and sexual orientation discrimination. State and Federal Courts and law enforcement spend most of their time trying to arrest and prosecute her on bogus charges.

While State and Federal brothels continue to flout violations of the Rule of Law,

He can sabotage her job performance by chipping away at her self-confidence, wearing her down emotionally and physically with arguments, interrogation and manipulation. torture and sweat labor continues to be inflicted on this author without due process and compensation. Since 1995 they have continued [[and are doing so at this very moment](#)] to rob Kini of all human rights and have deprived her of excessive property and financial funding so that she is deviated to slave and abusive labor practices at excessively less than \$5/hr.

To not be held accountable, U.S. officials are continuing to batter Kini Cosma with severe forms of slander and libel so as a female sex offender, she will continue suffering life as a human battering instrument knowing provoked sexual and psychological harassment with unsustainable wages will make her vulnerable and she will have to be dependent upon and service American men.

**The acquisition of the female sex offender status was achieved by:**

- 1. violations of speedy rights to trial where time gives prosecutorial misconduct and police misconduct a chance to incubate;**
- 2. advance informant/snitch and false witness testimony;**
- 3. Manipulative tactics designed to coerce false confessions and coerced guilty pleas regardless of the truth;**
- 4. undetected progression of fraudulent science and debunked theories;**
- 5. misrepresented evidence, evidence tampering, ignored evidence, trickery and deceit, reporting of inculpatory results from tests not conducted and concealed exculpatory evidence;**
- 6. witness intimidation, knowingly using presented perjured testimony**
- 7. bad lawyering. So bad, it's like not being represented at all. He did not meet with me, did not understand facts, did not hire experts, had not investigated, had not reviewed discovery, had not subpoena'd or called defense witnesses, could not possibly cross-examine state's witnesses, or object to objectionable arguments, more likely than not would not argue motions or closing statements effectively.**

The serial abusers, *inter alia*, have been law enforcement officers from the cities of **Napa and Susanville in California to Klamath Falls in Oregon, State and Federal Judge Magistrates** and other officials who are highly skilled at abuse without being detected. The use of excessive psychological and physical abuse is being used to

publicly destroy this author's credibility by provoking behavior then indicating "she is unstable and has a psychiatric history." They have discouraged and prohibited community neighbors from aiding this author while forcing her to live in abject poverty. Actions taken and not taken for the primary purpose of inflicting pain; an unequal status within society amounting to hostile and belligerent acts of abuse against this author as further measures to mature other criminal purposes.

Among the property taken was an illegally seized \$100k rightfully inherited trust estate funds by Alco Metals (<http://www.alcometals.com>). This was authorized by U.S. officials so that Kini Cosma would have to suffer years of lost business entrepreneurship, joblessness, and other lost opportunities to frustrate purposes of productivity.

The most recent stint of harassment occurred on January 1, 2010 (and on February 26, 2010), the Klamath County Sheriff's dept, animal control officers, and code enforcement deputized another punk to occupy her horse space for days forcing her to be blocked out so that she could not feed or water her horses. These desperate measures to strengthen the current pending malicious prosecution will more likely than not continue until the **“new trial date“ on June 24<sup>th</sup> at 9:00 am.**

U.S. officials are claiming these actions are occurring as a result of "harmless error" when in fact there is a pattern of conduct by U.S. officials completely apparent that Kini is being forced to defend herself in grueling jobs of massive malicious prosecutions with no pay and no end in sight, INDEFINITELY. This deliberate malice by U.S. officials is occurring without providing Kini with family communications<sup>2</sup>, resources, compensation, or colleague support so that she will rot in abject poverty.

<sup>2</sup> Kini Cosma long suspected that her Jewish sons were removed for religious reasons. The “Christian” case worker no doubt was a fanatic obsessed with Christianity.

None of this behavior is exclusive to systematic infringers who continue to use psychological warfare, corporate greed, and enhanced techniques while claiming “THE FIFTH.”
