

"WOMEN SUFFERING IS OUR VICTORY!"
SAY THE JEWS AND *THEIR* COLLABORATORS

COME TO THE DEFENSE OF POPE PIUS XII AMID CRITICISM OF THE JEWS
DON'T LET THE JEWS MAKE A MOCKERY OF THE VATICAN

The Vatican has recently sought to quell its latest public dispute with Jewish groups, saying the pope's decision to move Pope Pius XII closer to sainthood **IS NOT** an act of hostility against those who say he didn't sufficiently denounce the Holocaust.

Benedict sparked renewed outrage among some Jewish groups by assigning a decree on Pius' heroic virtues, paving the way for him to be beatified once a miracle attributed to his intercession is confirmed.

Some Jews and historians have argued Pius, pope from 1939-1958, should have done more to prevent the deaths of 6 million Jews at the hands of the Nazi and their collaborators during World War II.

The Vatican insists Pius used quiet diplomacy to try to save Jews and that speaking out more forcefully would have resulted in more deaths. Benedict said Pius showed great "attention and preoccupation" over the fate of Jews.

Yet, the decision was the latest in a series of perceived affronts that have roiled Jewish relations in recent years. Patterns of harm that seem to have emerged in Jewish dialogue involving missteps followed by less-than-convincing explanations and rationalizations.

The Vatican responded to the ensuing criticism by issuing clarifications, explanations or apologies after the fact-including a remarkable papal admission that mistakes were made when the full extent of the Holocaust was denied.

Even though Benedict couldn't mention everything every time he spoke, it wouldn't have mattered. According to the Jews, it wouldn't have been good enough!

For instance, Pius, a Vatican diplomat in Germany and the Vatican's secretary of state before being elected pope, did denounce in general terms the extermination of people based on race and opened Vatican City to refugees, including Jews, after Hitler occupied Rome in 1943. And, consider Benedict's own past- he was forced to serve in the Hitler Youth and deserted the Nazi army-and his stated aim of continuing to improve relations with Jews.

This author, who is Jewish, has stressed that the dignity of the human person is the foundation of the promotion and defense of her inalienable rights. Yet, this author has been met with violence in its various and everchanging forms (terrorism, exaggerated nationalism etc.) instigated by the Jews and their collaborators.

When this author mentioned the words "woman" or "violence against women" to a Jew, they are unable to apologize for their part in the horrendous human right violations of this author. They

neither encouraged esteem, hope, self-worth, potential self sufficiency, peace of mind, security about dependents, well being, health, happiness, a good life. They refuse to address, *inter alia*, powerlessness, vulnerability, conflict resolution, social protection, affiliation, cohesion.

Sadly, it is the Jews and their collaborators who have:

1. screamed afoul with their beliefs that Kini is "Anti-Semitic" when in fact she is a Jew who they've denounced. (Most evidence uploaded at <http://appeals4justice.zoomshare.com/>)
2. wrongly scapegoated and criminalized Kini because she is a lesbian deceiving and poisoning various communities that she is a danger to herself and others by, *inter alia*, slandering and libeling her as a "stalker" and "sex offender"
3. robbed Kini of all her Jewish creativities and talents (See three resumes) so that she is deviated to slave labor at less than \$5/hr. They completely drove her from the workforce as a result of a breach of U.S. Government promise to work in the legal field earning extensive wages. (See **Human Trafficking** <http://judiciary.zoomshare.com>) To1day, Kini is being forced to defend herself in massive malicious prosecutions with no end in sight and without compensation or colleague support.
4. used the smallest details of every day life as snares hoping to entrap much larger quarry; actions that are being permitted to forcibly change her very ability to formulate particular thoughts and are contributing to the hateful expressions to tally its score in the forms of making ALL LEGAL ACTIVITIES ILLEGAL. 5. illegally seized \$100k rightfully inherited trust estate funds by the Jews of Alco Metals (<http://www.alcometals.com>) so that she would have to suffer years of isolation in a world of the heathen: punks, police bullies and their lying informants, the sloth and twit, the drunk and drug addict, and those with the banality of low mental acumen who have been given authority to constantly offend verbally and tear apart with taunts, cripple with scorn and fiercely threaten with sexual physical assaults. And, so that she would be vulnerable and have to be dependent upon and service American men;
6. advanced cognitive decline by invoking isolation from society, robbing her of her vigor, disabling and crippling with constant threats of early placement in mental institutions, adult foster care, provoking and instigating agonizing physical and emotional pain using a cataclysm of fear through rogue cops.
7. disguised invective behavior as every day occurrences while coaching the community in government-organized systems of cruelty and injustice and bantering her as being mentally ill, criminally insane using sadistic theories to inflame this author's passions so that some Jewish groups argue, "The number of unbalanced people and their aggressiveness can increase." 8. rendered powerless, unsupportive, and silent, Kini's 1st cousin, Alan H. Lazar, Federal Magistrate. (<http://lazaradr.com>) et al and whose father, Kini's uncle, was a physics engineer at Lawrence Livermore Lab in California,
9. became a tormentor in this ignored and dismissed case. (<http://violence-against-womens-act.blogspot.com>)
10. found it necessary to leave Kini without contact or concern to rot at the hands of the heathens to render apart (Michael Olden, attorney at law, in Oakland, California)

While the Jews and *their* collaborators continue to experiment with solitary confinement, sensory deprivation, threats of physical, sexual and psychological violence, health consequences of psychological torture, psychological abuse and control of this author by intrusive acquaintances, the overwhelming evidence of facts is that it is widely, generally and almost unanimously accepted; that the abuse against this woman is considered normal and is absolutely tolerated.

Matter of fact, this author's campaigns are being held up as treatment for ridicule and used as mockery of everything whenever possible. This is so she will be subdued to vulnerability, suggestion, and intimidation far beyond the boundaries of public dissent.

Yet, those who are educated about the experiences and horrors of the Holocaust, the pain of the silence, the unease by blithe indifference to the historical record, have tolerated the torture of this Jewish woman in America for 15 years.

As this Jewish author suffers in *their* silence, they say Benedict didn't issue public indictments of Jewish deportations because he cared more about bilateral relations with Nazi Germany and the rights of the Catholic church there than saving Jewish lives.

Regardless, it remains to be a culmination of a long personal odyssey for this battered woman where she feels she had no choice but to flee her homeland to protect herself against the horrific abuse at the hands of the Jews and their collaborators; law enforcement officials, the State of California, cities of Napa and Susanville, and the judiciary who offers no protection to this domestic violence victim; And, who remains faced with persecution on several levels based on political opinion, gender, sex orientation and membership in a particular social group.
